Young carers from across the Commonwealth have developed this Charter, grounded in the United Nations Convention on the Rights of the Child.

18 young carers from eleven countries have contributed to a pan-Commonwealth video promoting the Commonwealth Charter for Young Carers. They call on Commonwealth Heads of Government to endorse the Charter at their forthcoming meeting in Samoa in October 2024.

The video illustrates - through the comments of young carers themselves - the similarities and differences in the experience of young carers in different Commonwealth countries and contexts. Whatever the differences, one powerful message is consistent: ***'to support us, listen to us!'***

The video is a contribution to the Commonwealth Year of Youth, with funding promised by the Commonwealth Secretariat. It is the result of a multi-national partnership which included the UK Carers Trust, Hospice Toronto, the Noel & Thea Jones Fund, Little Dreamers (Australia), Carers Worldwide (India and Bangla Desh), Olive Community Development Initiative (OCDI, Nigeria), Camp Unity New Zealand, and social work associations in Kenya, Tanzania and Uganda. It was put together from conception to final editing in under one month, with music from poet, musician and Commonwealth Young Carer Champion Oritsé Williams and editing by Jo Leach: a remarkable testimony to pan-Commonwealth commitment and shared achievement!

The video was first shown at the inspiring international young carers conference at Manchester Metropolitan University in April 2024 [<https://eurocarers.org/iyc-2024/>].
