

COSW CONTRIBUTES TO PODCAST EXAMINING THE TRUMP EFFECT ON AID AND DEVELOPMENT

COSW contributed to a podcast which explores the impact of sudden, wholesale cuts to the USAID funding on health and social services across the global south. The cuts have harmed individual and community health and created substantial unemployment. Media attention has moved on but the destruction and pain remain.



The discussion covers the impact of United States foreign aid cuts on the Commonwealth countries and beyond. The speakers highlight the significant repercussions for vital areas like healthcare, education, food security, and stability in crisis regions, particularly affecting vulnerable populations. They emphasise the sudden and devastating nature of the cuts, which disrupt established programs and livelihoods, and call for urgent cooperation among Commonwealth nations to address the resulting funding gaps and explore alternative support mechanisms. The conversation also touches on the wider context of global development assistance and the need for a sustainable, well-planned approach to supporting health workforces.

To understand the impact and the necessary response, the podcast had input from:-

- **Zeni Thumbadoo** (social worker and Deputy Director, National Association of Child Care Workers, South Africa) on managing the cuts in her organisation
- **David N Jones** (IFCO: Independent Forum of Commonwealth Organisations and Commonwealth Organisation for Social Work) and **Yinglen Butt** (Commonwealth Nurses and Midwives Federation) on the impact across the Commonwealth and submissions on health and wellbeing workforce to the Commonwealth Health Ministers Meeting in May 2025
- **Judith Diment** (Coordinator Polio Eradication Advocacy Task Force, Rotary International) of the impact on polio eradication
- **David Gomez** (Director, Ramphal Institute) who provides a a pan-Commonwealth overview and considers likely consequences
